

**NOTICE TO CONTRACTORS
FOR THE CONSTRUCTION OF
SANITARY SEWER LATERAL REPAIRS IN
MATTYDALE, GALEVILLE AND LYNCOURT
TOWN OF SALINA**

Sealed bids for the construction of the Sanitary Sewer Lateral Repairs will be received by the Town Clerk, Town of Salina, Onondaga County, New York, at the Salina Town Hall, 201 School Road Liverpool, New York, 13088 until 2 p.m. local time, April 9, 2018 and there at said office, at said time, publicly opened and read aloud.

This project provides for the construction/repair of approximately 17 sanitary sewer laterals located in Galeville, Lyncourt and Mattydale in the Town of Salina.

The Contract Documents consisting of the Advertisement, Instruction to Bidders, Bid, Agreement, General Conditions, General Specifications and Contract Drawings may be obtained from C&S Engineers, Inc., 499 Col. Eileen Collins Boulevard, Syracuse, New York 13212. Contract documents will be provided electronically.

Copies of the above-described Contract Documents may be examined at no expense at the Offices of the Town Clerk, Town Hall, 201 School Road, Liverpool New York, 13088; and at the office of C&S Engineers, Inc., 499 Col. Eileen Collins Blvd., Syracuse, New York 13212.

Each bid must be accompanied by a certified or bank check or a bid bond payable to the Town of Salina, in an amount not less than five percent (5%) of the amount of the total bid as a guarantee that the Bidder will enter into the Contract if the project is awarded to said Bidder, and also in the form and subject to the conditions provided in the Information for Bidders. If upon acceptance of said Bidder's Bid, a Bidder fails to enter into a Contract with the Town of Salina, the certified or bank check or bid bond shall be forfeited to the Town of Salina.

Bids must be submitted in sealed envelopes with the Project Name plainly written on the outside. No Bidder may withdraw his Bid within 45 days after the Bid Opening. The successful Bidder must furnish Performance and Payment Bonds, each in an amount at least equal to the Total Bid, with a surety authorized to do business in the State of New York and acceptable to the Town of Salina.

Bidders are not to include in their Bid, sales and compensating use taxes of the State of New York and of counties or cities on materials, equipment, and supplies to be incorporated into the Project. Minimum Wage Rates shall be the prevailing wage rates as determined by the New York State Department of Labor.

The General Municipal Law of the State of New York requires that Bidders certify, under penalty of perjury, that the Bids have been prepared without collusion with other Bidders, subcontractors, suppliers, etc. A certification is included with the Bid Proposal that each Bidder must sign in the space provided.

The Town of Salina reserves the right to waive any informalities in the Bid and to reject any or all bids offered.
